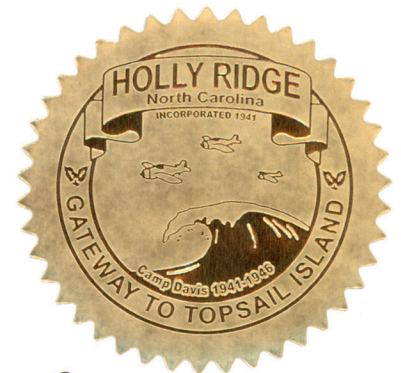
**Call for a Public Hearing on the Possible Text Amendment to the Definitions in the Zoning Ordinance.**
